

COMPLETENESS AND HEDGING IN A LÉVY BOND MARKET

We consider bond markets with one factor where the noise is a Lévy process. By beginning with the dynamics of the short rates under the historical probability we consider the bonds as derivatives valued under certain risk neutral probability. The completeness problem is analyzed by using new representation theorems for martingales with jumps with a view towards hedging.
